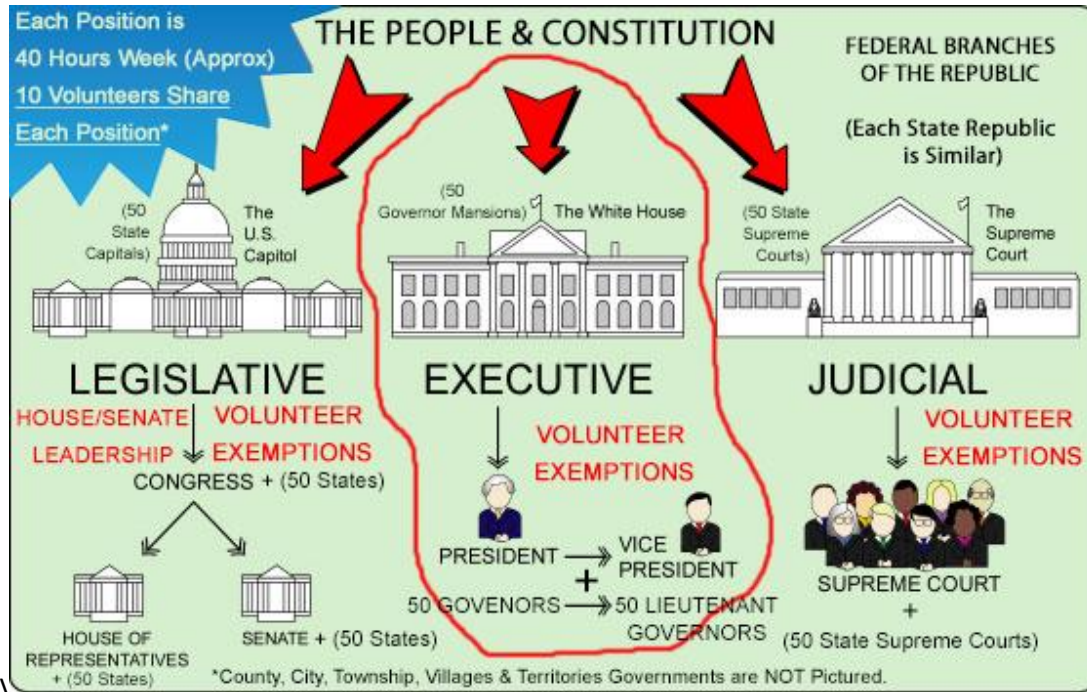

- City Parks & Wildlife Preservation Maintenance such as Work Crews for Landscaping, Graffiti Removal & Other Dept Duties.
- Highway & Roads Maintenance such as Work Crews for Mowing Grass of Roads, Highways and other duties.

COMPETITIVE CORPORATE TAX RATE*

- The Corporate Tax Rate For All Industries Should Be CUSTOM PER NAICS/SIC Codes Such As Automobile Manufacturing, NOT Many Countries Do It, WE NEED THE TAX RATE EXTREMELY COMPETITIVE WITH OTHER COUNTRIES. **A NATIONAL AVERAGE WILL ALSO RENDER THE NATION SUCCESSFUL, A SIMPLE FLAT RATE, 1 SIZE FITS ALL ISN'T PERFECT YET BETTER THAN MOST.**

High Tax Rates Create a TRADE DEFICIT. (The Romans had a Trade Deficit with China and others as well, history repeats, between hand out welfare spending without a return and trade deficits the government couldn't afford its own military, amongst other factors, ultimately leading to its downfall). The United States of America has had a Trade Deficit since 1980 that started under President Jimmy Carter's extremely excessive 55% Corporate Tax Rate and this still has NOT been resolved. The Price of American Products/Services must be Competitive with world markets so that American Products/Services are Price Competitive with Foreign Countries, this is NOT happening. The More Products/Services American Companies sell, the more tax revenue for the government. We currently have been running a Trade Deficit of 100s of Billions of Dollars annually because Higher Taxes on Companies are stopping the company from investing into more employees & materials to create more products & services which is hindering the Shipping of Exports Because There are LESS SHIPPED OUT than our competitors. This is what is called an "Economic Bleed" and America's Economical Bleed is at an alarming rate. In Addition, The Competitive Tax Rate will also create more jobs for the Volunteering Elected Officials to Work in the Private Sector in cooperation with American Businesses. (No Tax Rate is Specified, IT won't be much lower, but low enough to help deploy our Branches of Government's Part Time Work Volunteers while maintaining ample domestic employment opportunities).

FAIR TAXATION FOR \$START-UP BUSINESSES*

\$start-Up Businesses DO NOT Need 3rd Party Investors or Loans, We MUST remove the ignorant road blocks to business success by allowing Businesses to begin and grow. All NAICS/SIC Codes and All Business Tax Structures must have extremely low payroll taxes from the beginning for the 1st Employee. NO Social Security & Medicare match by Employer & Employee, pay Social Security & Medicare 1x NOT 2x for the 1st Employee and 50% Federal Withholding & State Income Tax 30 Years. The Reality is that NOT EVERYONE IS STARTING BUSINESSES, MOST OF THE PEOPLE ARE EMPLOYEES AND WORK FOR A BUSINESS THAT THEY DO NOT OWN, IT'S IMPOSSIBLE TO START A BUSINESS AND PAY FOR LIVING EXPENSES AT THE SAME TIME. BUSINESS OWNERS NEED Reduced Payroll Taxes for the 1st Employee aka Founder by the Federal & State Governments. **A 10 Year Draw for Payroll Taxes paid back in Monthly Payments over 20 Years; 10 years beginning from the 1st Dollar of Revenue.** Typically need to build a business to offer it's products/services and that takes time. The SBA does 30 Year Business Loans it's time we had a \$start-Up with the same time allowance. In return the Business Founders are to purchase 70-80% All American Products & Services from Non-\$startUp Business Vendors & Suppliers for both creating & maintaining businesses in addition to personal purchases.

- Unemployment Tax for the Founder/Owner of any and all companies regardless of NAICS/SIC Code and Business Structure will be revised to be exempt for the first employee. When a New Business Owner starts a business leaving employment with another company 2 jobs are created; Their Previous Job becomes available for the Unemployed to take advantage of and they create their own job. The FUCA (Federal Unemployment Compensation Act) and State Unemployment Compensation Acts DO NOT Consider this reality.
- Starting a Business is a Risk, The Bold Entrepreneurs that venture into starting businesses deserve to take the risk. Has Stated NOT every person starts businesses; Until a Business achieves enough revenue to pay employment taxes they should NOT be required to pay Sales Taxes or any other Taxes, SIMPLY PURCHASE AMERICAN, STRICT DOMESTIC PURCHASES, LOCAL/STATE/REGION/NATIONAL, 70-80% OF PURCHASES MUST BE BOUGHT FROM DOMESTIC COMPANIES. Each business, regardless of NAICS/SIC Code and Business Tax Structure, should be allowed to make such a risk as to starting their business. A 10 Year Risk period should be allowed for each new business owner to begin their businesses, reducing their social security, medicare & income tax payments for the life of the Business. Business Owners CAN NOT Run Their Businesses by themselves, they need vendors, suppliers and partners IF they can't afford employees but ultimately they will hire employees thus creating jobs of course purchases from Vendors, Suppliers and Partners are also a huge contributor to creating & maintaining Jobs. Every NAICS/SIC Code and Business Tax Structure have very large competitors, New Businesses Owners need less obstruction to compete against the Millionaire and Billionaire Businesses in their industries.

GOVERNMENT ASSISTANCE PAYBACK RETURN

- No Hand Outs (Welfare) or other monies shall be given to any person from the Government without a responsible return (Exception Children Care Related Assistance, of course most states have long pursued the parents for support etc IF assistance is used.) IF a person receives housing or monetary assistance that person is responsible to pay back the full amount or value to the government. A 1% - 10%, LIFE & case by case Adjustable, Flat Rate Return shall be applied to any and all assistance. IF a person does NOT pay back the Government after reasonable collection efforts and time then a tax intercept shall be used to enforce payment and/or other wage garnishments. This is NOT to be enforced immediately, 5 - 20 Years after last assistance is received will be a typical time frame to begin possible repayment arrangements.
